Packing

We strongly recommend you have exhibit material packed carefully and professionally for shipment to and from Dubai. Bolted, returnable standard cases should be used. For cartons of brochures and or giveaways, use pallets and shrink-wrap to secure and protect the smaller boxes. Whilst UAE have not yet implemented the ISPM15 regulations it is recommended that any solid wood packing is ISPM15 compliant as this will be necessary for any returning or on forwarding to countries that have implemented it. Insurance

Please ensure that your goods are covered by Insurance for the round trip. EFI can arrange this on your behalf on receipt of instructions prior to shipment. EFI's liability is limited by their standard trading conditions (BIFA 2005A) a copy of which is included with these instructions, available on request or at their website www.efilogistics.com

INTERNATIONAL SHIPPING INSTRUCTIONS

Arrival deadlines

Shipments should arrive in Dubai up to one week before and **no later than** the following dates for each method of transport:

By Sea – to Dubai Port or Jebel Ali Port

Sea/ ocean freight LCL/ groupage . . . 17th November 2012 Sea/ ocean freight FCL (20' or 40' container) . . . 19th November 2012

By Air - to Dubai Airport

Airfreight consolidation (HAWB) . . . 19th November 2012 Airfreight direct/ back-to-back (MAWB) . . . 21st November 2012

Goods must be consigned correctly (see below). Goods arriving +2 days before these dates will attract additional storage and handling fees. Copy commercial invoices should be sent to EFI 15 days prior to the show for checking and a full pre-alert for all shipments must be sent to EFI at least 5 days for Seafreight & 24 hours for Airfreight prior to arrival in Dubai.

Documentation Requirements

Copies of the following documents must be sent by e-mail to colin.huckle@efilogistics.com or fax to +44 1444 237749 prior to arrival of shipments in Dubai:

Seafreight Shipments – Documents Required

- A: Original Shipping Line Bills of Lading consigned as above
- B: Original Commercial Invoice (see below)
- C: Original Packing List showing individual weight of the packages and total weight in conformity with the Bills of Lading
- D: Certificate of Origin (No legalization required)

Airfreight Shipments - Documents Required

- A: AWB Consigned as above
- B: Original Commercial Invoice (see below)
- C: Original Packing List showing individual weight of the packages and total weight in conformity with the AWB

Commercial Invoice

For customs clearance we require a commercial invoice / packing list typed on your letterhead and must be addressed to your stand at the show. They must show number of packages, itemised description, make, model, serial numbers, itemised values and total CIF value with the following clause "Goods are for exhibition purpose to be exported after the show"

Please contact EFI for a sample copy invoice.

Manufacturer's name and address must be shown for all items and printer and publishers name and address must be shown for all printed matter. Each invoice must include the following paragraphs appropriate to the goods you are sending.

- We certify that items (1-) are manufactured by (company name) and (address).
- We certify that the literature is printed by (company name) and (address) and published by (company name) and (address).

In addition each invoice must also contain the following clause.

➤ We hereby certify that the goods are of ______ origin and that no parts, labour or capital of Israeli origin were used in their manufacture.

Invoices and Packing list must bear your company stamp and be originally signed in blue ink.

Censorship: Audio Visual Films and Cassettes

Films, Videos and Slides are subject to censorship in the U.A.E.

All such items must be in English language and should be sent at least 30 days prior to the show. These Items must be sent to:

You should prepare a pro-forma Invoice to cover the dispatch of these audio-visual items.

Certificate of Origin

For **sea freight only** shipments will require a Certificate of Origin. This should be obtained through your local chamber of commerce; the chamber of commerce must certify this. It does not need to be legalised by the UAE Embassy or Consulate.

If you need help completing your documentation for this show please contact the EFI customer service team at any time.

Customs Duties

Customs duty @ 5% of CIF value plus advancement fee will be charged on all item remaining in UAE after the exhibition - this includes all give-aways, stand materials and exhibits. Any shipments where total Duty liability is less than US\$ 100 will be entered as permanent regardless of whether or not they return. Temporary importation without payment of duty is subject to bond fee (see tariff for details)
